# **Courses Taught in English at the Faculty of Law**

**Course Program for Exchange Students** 





## Introduction

The Faculty of Law at the University of Regensburg was founded in 1967 and it is one of twelve faculties of the University of Regensburg.

Currently, the faculty consists of 20 chairs and has approximately 2,500 undergraduate (state examination and LL.B.), PhD and LL.M. students. It offers an extensive and excellent law program with an outstanding service during the entire study period.

The study of law provides in-depth knowledge in the most important areas of law. The focus of the education is on civil law, criminal law and public law. One deals with all aspects of social coexistence in which legal rules are applied. Those who study law train their eye for the economic, social and political contexts that shape our society. In addition to scientific methodology, special attention is also paid to the practical application of the law. The standard period of study is ten semesters. The university education is completed by the First Law Examination, which consists of a state examination (Erste Juristische Staatsprüfung) and a university examination (Juristische Universitätsprüfung).

#### **Course Offer in Law:**

All full degree programs in Law are taught in German, as the faculty prepares students mainly for the German state examination for law. For this reason, almost all courses are taught in German. However, in order to increase the qualification of UR's students as well as the attractiveness to exchange students, several courses taught in English have been established over recent years. This program is directed at advanced bachelor students as well as master students.

In addition to several core courses, the faculty takes great efforts to invite international guest professors and scientists for individual block seminars to our university and offers independent study options in order to provide exchange students a sufficient number of ECTS for a semester in Regensburg.

### **Course Offer outside of the Faculty of Law:**

Students may also take courses from other areas/faculties at UR for their elective modules at home. In the past, students of law have often taken courses from history, business, or political science to add to their course list.

Furthermore, students are welcome to improve their German language skills by participating in the program offered by UR's **German as a Foreign Language Unit**.

#### **Language Requirements:**

Students wishing to take courses from the English-taught course program must have English knowledge on level B2 (according to CEFR) or better.

### **Intensive Language Course in German:**

For all students who come to UR and have no or only very limited knowledge of German, we recommend participation in our pre-semester intensive language course (ILC). It takes place 5 weeks prior to the beginning of the regular semester and comprises 120hrs of German instruction as well as orientation on campus and the city, and extra-curricular activities.

## **Categories of Courses**

To sum up, exchange students coming within an exchange program in Law may choose from the following categories of courses:

- Courses from the Faculty of Law
- Courses from other departments and faculties like European Studies, Politics, History, or any other department that offers courses which are accepted as electives by our partner institutions.
- Courses from the "German as a Foreign Language Unit"
  - Pre-semester Intensive Language Course
  - German language courses during the semester
- Special Courses for International Exchange Students with a Focus in German and European Studies and Culture e.g.:
  - Perspectives on German Culture
  - Intercultural Communication
  - Sociological and Political Perspectives on Modern Germany
  - Courses from International Politics

#### Additional Studies

By special arrangement, you can complement appropriate courses (e.g. Climate Change Law and Litigation, European Convention on Human Rights, Law of International Relations, Transnational Protection of Human Rights) with additional studies such as a short thesis in order to earn up to 8 additional ECTS. Please contact the respective professors for further details. If you understand some German, you may also participate in a seminar of professor Graser, Krämer-Hoppe or Uerpmann-Wittzack and present your paper in English.

Students are free to combine courses according to their needs unless the home university requires differently.

## **I. Course Descriptions – Winter Semester:**

## **Introduction to European Law – Lecture**

This lecture features the complete mandatory range of this fascinating, dynamic, and important legal area. Starting point will be the inner constitution of the European Union, which will lead to an understanding of the most basic provisions, rules and mechanisms of the European contracts and the different areas of politics within the EU. To ensure the best possible preparation for succeeding in written examinations, the law of the European Union will be presented embedded in actual, recent cases that might be subject to assessment during the exams in this very form. This approach also trains to cope with problems that may arise at the boundary point of EU law and national law.

## **Introduction to Comparative Law and Legal Transfer – Lecture**

Comparative law and legal transfers are of great practical importance. Almost all legal reforms nowadays are based on comparative research. Frequently, there are veritable "legal transplants" from other legal system to another. This considerable practical significance is reflected in the vast amount of research devoted to comparative law. In education, however, this field has played but a minor role. Nonetheless, when dealing with foreign law (for example, in the context of studying abroad), some basic knowledge of comparative law is no doubt helpful.

This is where the course comes in. Drawing on examples from different legal systems and sectors, it will review the fields of application of comparative law, define its goals, explain its approaches, and address frequent errors. The course is open to all law students. It may be particularly useful for those who will soon be studying abroad or who are currently in Regensburg as exchange students.

Furthermore, for those who are interested, the course also offers the opportunity to study the topic somewhat more intensively. Thus, in the second part of the lecture, individual topics are dealt with in depth, especially from the area of legal transfer, and there is also the possibility to write independent papers (in addition to the regular course work and with the possibility of earning additional ECTS).

The course comprises a total of two SWS (4 ECTS), but can be divided: Those who are only interested in an introduction to comparative law can limit themselves to attending the first half of the course - corresponding to one SWS (2 ECTS). If required, corresponding examinations are offered for the acquisition of ECTS - in the form of oral or written examinations.

Participants prepare seminar papers and give a presentation on their respective topics, which is then discussed in class.

## **Contract Drafting – Block Seminar** <sup>2</sup>

Students who plan to work in a major law firm should know that an essential part of contracts there is drafted and negotiated in the English language. The course will prepare students for that kind of work and will provide decision guidance for students thinking about taking up work in that field. The course does not intend to improve English language skills. The aim is to show how contracts, based on German law, are to be drafted in the English language. The course will be held partly in English and partly in German. Medium to good knowledge of English and German is sufficient.

There will be a balance between practical exercises and theory.

### Arbitration Law – Lecture 2

Arbitration is the preferred method of dispute resolution in (international) corporate litigation. This is especially true for cross-border situations and for corporate disputes. The lecture covers the basic knowledge of arbitration law, including the advantages and disadvantages of arbitration, the legal bases of arbitration (e.g. Chapter 10 German Code on Civil Procedure, New York Convention, IBA Guidelines, UNICTRAL Model Law) and arbitration institutions (e.g. ICC, DIS). Moreover, the lecture presents the drafting of an arbitration clause, the arbitration process as well as the acceptance, repeal or enforcement of an arbitration award. The lecture and the examples given will especially focus on arbitration in corporate disputes.

The lecture is held in English and addressed to students in the 5th semester or higher. References to books and cases are given during the lecture.

#### Law of International Relations – Lecture

The course deals with core issues of public international law such as the law of diplomatic relations, prohibited use of force and self-defense, peace keeping and peace making within the United Nations, the law of armed conflicts, immunities, and dispute settlement through international courts. Recent state practice will play an important role. A tutorial complements the course. In the tutorial, special focus will be laid on the sources of international law, the law of treaties and the law of state responsibility. You may attend the course without previous knowledge.

Course materials will be distributed in class; a pdf version will be available in Regensburg's e-learning platform "GRIPS". If coronavirus restrictions persist, the course will be taught online.

Exchange students have to register for the exam in a list provided by the professor; please do so in the very first lesson. Please check the course materials in GRIPS for further details once you are in Regensburg. Assessment: For students who attend both the lecture and the tutorial: 75-minute final exam. For students who attend the lecture by itself: 60-minute final exam. Sample tests will be available in GRIPS.

### Law of the International Relations – Tutorial

## **II. Course Descriptions – Summer Semester:**

### **European Convention on Human Rights – Lecture**

The European Convention on Human Rights (ECHR) binds Germany and 45 other member States of the Council of Europe, from Azerbaijan to Cyprus, from Iceland to Turkey, and from Portugal to Finland. Its implementation is monitored by the European Court of Human Rights in Strasbourg. The course deals with European human rights theory, with selected human rights such as freedom from torture, freedom of expression or the protection of private life, and with the functioning of the European Court. Although the ECHR and the Strasbourg Court do not belong to the European Union (EU), interactions with EU law and with the EU Charter of Fundamental Rights in particular, will also be addressed.

## Convention on the Rights of Persons with Disabilities/CRPD

The UN Convention on the Rights of Persons with Disabilities (CRPD) is a modern human rights treaty, which combines a strong anti-discrimination approach with a wide range of substantial guarantees and an innovative implementation mechanism. The Convention stands for a paradigm shift from a charity based towards a human rights based approach to disability issues, which is marked by the slogan: "Nothing about us without us."

### **CRPD** questions are manifold:

- Do public transport services have to equip all bus stops with acoustic timetable information systems?
- Does the ban on hospital entry with a dog also apply to guide dogs?
- Is it appropriate to establish special schools for children with disabilities instead of sending them to ordinary schools?
- Can a person suffering from Alzheimer's disease be accommodated in a closed institution or denied the right marry or to vote?

The course introduces major concepts and provisions of the CRPD such as the prohibition of discrimination, the obligation to provide reasonable accommodation, accessibility, inclusiveness, and participation. Moreover, the course considers implementation and monitoring mechanisms, which exist both on the domestic and on the international level. Special attention will be paid to the UN Committee on the Rights of Persons with Disabilities and its practice. There will be enough time for discussing specific CRPD questions in class.

### **Learning Outcome**:

Students will understand basic concepts of modern disabilities law. Building on previous courses dealing with fundamental and human rights law, students will further their understanding of general human rights theory, and learn to apply it to specific questions of disability law.

Students should have followed at least one course dealing with domestic or European fundamental rights law or international human rights law before attending this course.

## **Transnational Human Rights Protection – Lecture**

The course deals with established structures and current developments in the field of human rights. National human rights provisions will be used as a point of reference, but the course will primarily deal with transnational law, focusing on both the global and regional systems of human rights protection. In addition, the course will cover mechanisms of human rights protection that transcend the national context but are not part of the global or regional systems.

## Law and Borders: The construction and meaning of borders for international migration – Seminar <sup>2</sup>

Migration is among the most salient policy problems of our time, both in Europe and beyond. The construction and function of borders lie at the heart of this problem. Our seminar introduces participants to the field of border studies and its relevance for migration policy. It places particular emphasis on legal perspectives, as in today's world, law and borders are inextricably linked: Almost all law is territorial, and hence defined by the borders it implicitly presupposes. Conversely, almost all borders are constituted not only by geography or culture, but also law.

More specifically, the course offers an overview of contemporary border issues in Europe which come into tensions with legal aspects of migration. It introduces the relevant regulations and explores the multidimensional issues experienced by individuals along borders and how they are affected by the law or conversely impact the law. Examples will range from every day latent conflicts on the European continent to tensions along European borders in Africa, South America, etc. While the primary focus will be the nexus between borders and migration, examples will be put into dialogue with the broader border studies scholarship to help students engage with the variety of border processes and theories. The aim of the course is to get the students familiar with the legal aspects pertaining to borders and migration in Europe, and make them every day critic of the various narratives surrounding them. An emphasis will be placed on the various visual data available to study borders and migration. One session of the course will be devoted to critical map making and map reading. This session will feature a lecture by guest Pr. Dr. Henk van Houtum, leading scholar in radical cartography, followed by an activity with students based on a dozen of conventional and unconventional maps, in order to infuse in them the desire to engage more with these topics beyond the course.

The seminar will be co-taught by Mélanie Sadozaï, a political scientist and specialist, i. a., in border studies, and Alex Graser, a lawyer with expertise in migration law. It is open to up to 25 students from all related fields. Assignments and the amount of ECTS conferred may vary depending on the requirements of the individual participant's module and should be agreed upon with the instructors. The expectation will written typically be seminar paper and an oral input As the course language is English, a solid passive knowledge of English is indispensable. Written assignments may be completed also in German or French. Students are expected to participate actively in the course. Accommodation may occasionally be made for students who prefer to contribute in other languages than English.

There will be a preparatory session (the info about the date will follow), at which we will present the overall plan, answer individual questions, and, if desired, agree on topics for individual papers. There will be another one or two introductory session(s) at the beginning of the summer semester. The rest of the course will be offered as a block seminar, most like on Fridays / Saturdays in late June / early July. (The session with Henk van Houtum is scheduled for June 27th).

## Climate Change Law and Litigation – Lecture <sup>2</sup>

This course deals with the core issues of Climate Change law. It is split into two parts. In the first part, a basic overview of climate change law with a focus on international responses to the climate crisis is offered. In the second part climate litigation and therefore national responses to the climate crisis in courts are analyzed. In this part, groups of students will present cases from different jurisdictions all over the world. Exam: Presentation of one case.

## **EU Fundamental Rights – Lecture <sup>2</sup>**

The course deals with European fundamental freedoms and rights. At the same time, it is a narrative about the development of the European Union. It describes its path from an economic community characterized by the internal market to a political union which also sees itself as a community based on constitutional values. Accordingly, it begins with the dismantling of customs barriers between the member states in the 1960s and ends with the case law of the European Court of Justice on social benefit rights based on Citizenship of the Union and Anti-Discrimination Law.

## **Litigation in the United States Court System – Exercise 2**

This course is designed to give students an introduction to courtroom litigation in the United States. Following an introduction to the history and structure of the U.S. legal system, students will take on the role of plaintiff and defense counsel in scenarios representing various stages of litigation, including drafting complaints and other legal pleadings, understanding and applying rules of procedure and evidence, conducting discovery, and prosecuting and defending cases in a courtroom setting. Students will prepare pre-trial motions and present arguments, conduct witness examinations and cross-examinations, properly present evidence, make and defend against common objections, and adequately preserve cases for purposes of appeal. This course will be in English. The final grade will be based on participation in class and a final multi-choice examination covering history, rules, and vocabulary. All necessary materials and readings will be provided via GRIPS. Because of the nature of this course, classroom attendance will be necessary. In the event any student is not able to attend a scheduled class or meet an assignment deadline, they will be required to file the same motions any attorney would to reschedule courtroom hearings or request extended deadlines.
